Consent minutes and agenda approval - 08.04.24 minutes approved. Current agenda approved.

Announcements- All RSC members encouraged to attend the Inter-Regional Communication Roundtable that meets on Oct. 20. Phil and Carol attended the Inter-Regional Roundtable for Chairs that met earlier today. It was very informative.

Mike attended the 2024 Nar-Anon Convention in Washington, DC last weekend. It was in conjunction with a NA Convention and the convention was very inspirational. Mike was a speaker. There were approximately 130 Nar-Anon attendees.

Reports

Treasurer's report - Doug emailed a written report to the group. Balance in the account is \$3,082. Donations received this month were \$209.00.

Home groups - Jean reported there are 37 total meetings in the region. 25 groups meet in person, 5 groups meet just virtually and 7 meet in-person with a Zoom option.

Website -Carol reported there have been 198 visits to the website in the last 30 days. 71 of them were first time visitors.

- 1. October 19 Fall Assembly Update** - The workshop committee has met twice and the workshop title has been confirmed...*Moving from Denial to Acceptance*. The speaker for the Assembly has also been confirmed. It is John S. From Charlotte. John will let the group know when he has a title for his presentation. Leland knows there is \$200 in the budget set aside for assembly expenses. Carol will work on getting a projector for showing the reports on a screen. Phil will contact Gina to ask about the tables in the room, if there is a podium, extension cords, location of lunch area, if there is a wall or screen to project the reports (Agenda, Budget, Treasurers Report). He will also clarify with Gina the location access and departure time. There also needs to be a delegate report. Mike will speak at the assembly about the needs of the conference (facilitator, secretary), the common welfare topics, and the 7th Tradition/financial status of the fellowship.
- 2. Contact with Region meetings update** - Carol attended the Asheville online meeting. Most (or all) of the attendees do not live in the Asheville area. Asheville also has a weekly in-person meeting.
- 3. Supporting the struggling Georgia Region** - the committee decided that this issue can be addressed at the inter-Regional Communications Roundtable on Oct. 20.
- 4. Indexing the Serenity Connection Articles** - Jean reported that the newsletter committee has not yet heard from the World Services Board on their proposal submitted several months ago, but Robert P. shared a tool that he developed to make the process simpler. It is hoped that the WSB will adopt his recommendation. Carol shared Robert's suggestion to the Serenity Connection in an email to this committee on August 5.
